

Social Service Funeral and Burial Fees by Region

1. Background:

In October 2008, The City Of Hamilton was requested by the Hamilton and District Funeral Service Association to provide a 100% increase to the approved Adult Full Funeral Service Fees. A report was prepared and presented to the Emergency and Community Services Committee (CS09014 [Emergency and Community Services Committee Agenda for January 21, 2009](#)) on January 21, 2009. The recommendation presented was to increase The City Of Hamilton Social Service Funeral Fees by 14.7%. This report was referred back to staff so that they may review and assess the additional information provided by the Hamilton and District Funeral Service Association and also to complete a survey of all Ontario Works delivery agents to determine current approved Social Service Funeral Fees.

On January 21, 2009, the survey of all Ontario Works and District Social Service Administration Boards was initiated.

2. Purpose of Survey:

The three main goals of the survey were to:

- Confirm the “current” Social Service Funeral Fees for each Ontario Works delivery agent across the province
- Confirm if other Ontario Works delivery agents were in negotiation to determine a new Social Service Funeral Fee
- Determine how the City Of Hamilton Funeral Fees rank in comparison to other Ontario Works delivery agents

3. Methodology:

A survey was sent electronically to all contacts which completed the May 2008 Thunder Bay Survey. Telephone contact was made with Ontario Works delivery agents who did not participate in the Thunder Bay Survey. There is a total of 47 Ontario Works Delivery Agents in Ontario.

The following are the questions asked of each delivery agent:

- What is your approved Funeral Service Fee?
- Has an increase been requested by your funeral homes? If yes, what is the requested being proposed?
- If you have already increased your rates based on the request, what sort of analysis was completed to come to the new rate? (cost comparison of market rates, cost of living, etc)
- Do you offer a different rate for immediate disposition (no visitation; direct burial/cremation)?
- What is the maximum cemetery fee?
- What is the maximum cremation fee?

This survey was conducted between January 21, 2009 and February 23, 2009.

4. Results:

There was a 100% response rate to the Funeral and Burial Survey. The survey results are attached below.

13 Delivery Agents have identified that they have received a request from their funeral homes to increase the approved Social Services Funeral Fees.

11 Delivery Agents have reported approving substantial increases in the approved Funeral Fees based on requests from their local funeral homes, the notable increases are as follows:

5. Additional Findings:

The following are important differences between delivery agents:

Funeral Service Fees:

- 4 delivery agents set one fee which is to cover the cost the funeral fee, cremation and cemetery cost (plot, opening and closing)
- 31 delivery agents set a flat fee for the funeral service. In some areas, the delivery agent requests that the funeral home to reduce the fee if a lesser service is provided (e.g. no visitation or service). In other areas, it is a flat rate regardless of the type of service provided.

Cremation Fees-there is a large variance in the actual fees paid for cremation. In addition, some noted differences in policies are:

- 10 delivery agents include the fee in the funeral service fee (note: 4 of the 8 delivery agents set one fee to cover all the funeral and burial costs)
- 4 delivery agents include the fee as part of the \$1,000 maximum burial fee
- 3 delivery agents set \$1,000 for burial and interment or \$1,000 for cremation and interment
- 1 delivery agent will not approve interment of cremated remains

Burial rates:

- 24 delivery agents adhere to the \$1,000 maximum fee for a plot, opening and closing services as outlined in the Cemeteries Act

Additional Disbursements:

In addition to the set funeral service fees, some delivery agents approve additional costs for clergy stipend, obituary in newspaper and urns

Low Income Funerals (non-socially assisted):

There are a few delivery agents that do not offer funeral services to low income residents. This question was not specifically asked in the survey, however, it has been reported that a resolution is being forward to the Ministry of Community and Social Services to include funeral services and burials for low income as a cost shared benefit.
