SUMMARY OF WORKPLACE INSPECTION:

- The Ontario Ministry of Labour received telephone notification on July 9, 2012 regarding an incident that took place on July 9, 2012 that resulted in a worker suffering non-critical injuries.
- The incident scene was reviewed.
- The eyewash station located in the Staff washroom was reviewed, but was not activated in a single motion, as outlined in the Canadian Standards Association (CSA) Standard for eyewash fountains. The eyewash station located in the Kitchen was reviewed, but was not activated in a single motion, as outlined in the Canadian Standards Association (CSA) Standard for eyewash fountains. Chemicals located in the Bath Room, Housekeeping closet and the Kitchen require an eyewash station, as indicated on the Material Safety Data Sheets. PLAN ORDER ISSUED.
- For guidance on eyewash fountain requirement please consult the Canadian Standards Association (CSA) or the American National Standards Institute (ANSI). Both organizations publish standards that outline the requirements for eyewash fountains.

EVALUATION OF WORKPLACE INSPECTION:

- A contravention of the O.H.S.A./90 was found, one plan order issued.


